1	Categorized disease reporting	All centres shall report all livestock disease events under three categories — Suspect, Probable and Laboratory-confirmed — using standard case definitions for each disease. NADRES shall carry a category field, and the confirmation status of each event shall be updated as laboratory results become available, so that early-warning signal (suspect/probable) and confirmed burden are both captured.	<i>Action: ICAR-NIVEDI to issue the case-definition sheet.</i>	Agreed
2	Coverage of animal diseases	Outbreak/epidemiological data for all priority diseases shall be presented at the ARM under the above categories. Laboratory-confirmed FMD shall be reconciled with ICAR-NIFMD, reflecting the complementary mandates of NIFMD (virus characterization) and NIVEDI (risk assessment, forecasting and zoning).		FMD data need not be presented at NADEN. NIVEDI may restrict its activities to disease its forewarning, unless the help is sought from NIFMD.
3	Sample referral to reference laboratories	Wherever feasible, representative outbreak samples may be forwarded to the designated regional/national reference	<i>Action: ICAR-NIVEDI shall publish a disease-wise / region-wise reference-</i>	Representative Outbreak samples for all the disease reported must be submitted to ICAR-NIVEDI and ICAR-NIVIEDI should make

4	Risk-based sentinel surveillance	The number and location of sentinel sites shall be finalized jointly by ICAR-NIVEDI and each State, prioritized by species, priority diseases and hotspots. State-specific plans (site, species, target disease, rationale) shall be recorded in the prescribed format provided. Active and sentinel surveillance are integral to NADEN and will not attract separate funding.	<i>Action: Zonal Incharges and PI of the respective centres to work together to finalize the risk-based additional sentinel sites.</i>	In addition to the sentinel sites (which are mostly based in Govt farms), NADEN may explore conducting sampling in predetermined animal markets. One of the duplicate samples may be sent ICAR-NISHAD by the respective NADEN centers.
5	Outbreak investigation	Each centre shall investigate outbreaks scientifically using the standard epidemiological format and present at least one full outbreak investigation at each ARM.		Agreed
6	Data consistency	All centres shall reconcile monthly and annual disease reports before submission and share corrected, validated datasets with ICAR-NIVEDI.		Noted
7	Fund utilization	Centres shall ensure timely and complete utilization of funds and, before release of the final instalment each year, indicate their capacity to utilise the balance; unspent funds may be reallocated to centres with greater need. Centres with low utilization shall submit a quarterly		

		expenditure plan and target at least 90% utilization by 31 March 2027.		
8	Uniform diagnostics	Uniform diagnostic kits and standardized testing protocols recommended by ICAR-NIVEDI shall be adopted across all centres for consistency and comparability of data.		Agreed
9	Capacity building	ICAR-NIVEDI shall publish an annual training calendar covering surveillance, diagnostics, outbreak investigation, epidemiology, laboratory techniques and data management.		Noted
10	Data infrastructure	The NADRES portal shall be updated periodically for new districts and villages (LG Directory); area PIN codes shall be captured mandatorily; and centres shall provide the latest Livestock Census data to enable revision of disease-specific sampling plans.	<i>Action: Nodal Officer, NADRES.</i>	Noted
11	State collaboration	Each Centre shall strengthen collaboration with State Departments of Animal Husbandry for surveillance, outbreak investigation and disease-control programmes.		Agreed
12	Sample quality	Standard operating procedures shall be followed for sample collection, labelling, packaging, transport and testing, avoiding duplication and ensuring proper identification and traceability.		Agreed

13	Vaccination-failure investigation	Continued outbreaks despite vaccination shall be investigated using a standard package — vaccination coverage, vaccine efficacy, cold-chain integrity, schedule adherence and characterization of circulating strains — with booster schedules optimized where required.		A SOP may be developed by NIVEDI for the centers to take up studies in case suspected vaccination break through incidences.
14	Haemoprotozoan diseases	Enhanced surveillance and intervention shall be undertaken in endemic regions, and diagnostic cut-offs established to distinguish clinical infection from carrier animals.		Noted
15	Collaborating Centre teams and presentation	The PI/Co-PI must attend and present at the ARM; no change of PI during NADEN+ implementation shall ordinarily be permitted except with prior approval. A uniform, concise presentation template (about 15 slides) shall be used, with accurate terminology and clearly defined epidemiological units.		Noted
16	Model validation and sample sharing	The NADRES prediction outputs shall be compared with district-wise outbreak data to validate forecasting models.		Agreed
