### OFFICE ORDER

**Sub:** Functioning of ICAR-NIVEDI, Bengaluru from **6 am on 10.05.2021 to 6.00 am of 24.05.2021**

The Chief Secretary and Chairman, State Executive Committee, Government of Karnataka vide order No. RD 158 TNR 2020 dated 07.05.2021 has issued revised guidelines to break the chain of COVID-19 transmission in the State of Karnataka and these guidelines shall come into effect from **6 am on 10.05.2021 and will be in force including and up to 6.00 am of 24.05.2021**. Therefore, the Institute cannot function in full capacity during the lockdown period. The Institute will however, function with minimal staff to provide and maintain the essential services during the lockdown period.

The essential services like Security, Housekeeping including disinfection, Estate Management, Water supply, Electrical maintenance, Biosafety Laboratory maintenance and essential laboratory services shall continue **with minimum possible manpower following COVID norms**. In this regard, the services of employees and contractual staff who are living within the campus and nearby the Institute need to be preferably availed. Hence, for the smooth movement of staff for attending the above mentioned services, respective PIs/Heads/AO will issue letters to such staff authorizing them to attend the essential and emergency services so that the same can be shown to the Traffic Police authorities.

All other terms and conditions mentioned in the office order dated 27-4-2021 shall remain unchanged and the same will be in force until further orders.

All the employees and contractual staff who attend the office during this lockdown period shall comply with COVID Appropriate Behaviour like sanitizing, wearing face mask and maintaining social distance in general.

This order shall be in force until further orders and is subject to orders / guidelines to be issued by the Government of Karnataka from time to time.

This is issued based on the instructions and approval of the competent authority.
