1. All orders should be addressed to the Director, ICAR-National Institute of Veterinary epidemiology and Disease Informatics (NIVEDI), Ramagondanahalli, Yelahanka, Bengaluru- 560064, Karnataka, India
2. All payments should be made in advance by demand draft (DD) payable at State Bank of India, (Branch Code 13282; IFSC SBIN0013282), drawn in favor of 'ICAR Unit- NIVEDI, Bengaluru' or NEFT/RTGS/IMPS into account No.10476393073 of NIVEDI, Bengaluru for the specified amount.
3. Fee may be revised from time to time as per guidelines of ICAR and Govt. of India.
4. Appropriate sample for each testing in good condition is to be supplied at NIVEDI during working hours. The samples must be accompanied by a covering letter, giving details of samples, correspondence address, phone, fax and email
5. Requests for supply or identification of cultures should be written by faculty members/ staff members of the organization. Directly request letters from students and research scholars will not be entertained.
6. The supply of culture will be subject to its availability and with the condition that the organization/ party/ institute will not transfer or sell these cultures to any other party and the culture will be used for the purpose for which these were procured and as per conditions envisaged in Material Transfer Agreement and undertaking that the Institute follow all requisite biosafety guidelines.
7. All cultures should be handled carefully, taking proper and established safety precautions. ICAR-NIVEDI will not be responsible for misuse or improper handling of the culture(s) received from ICAR-NIVEDI.
8. Purity, authenticity and viability of cultures are carefully examined by ICAR-NIVEDI. However, if there are any complaints about culture(s), please inform the Director, ICAR-NIVEDI within three months of the receipt of the cultures. The ICAR-NIVEDI will not entertain complaints received beyond this period.
9. The air freight charges (Rs 7500/-) and handling charges (Rs 500/-) per consignment will be extra for the supply of the kit.
